Coastline Plus® Awning Fabrics are warranted for a period of five (5) years from date of original installation against rot or excessive deterioration, excessive loss of strength or color change if they occur in normal use and exposure, including sun light and normal atmospheric chemicals. (Some color change is unavoidable due to ultraviolet rays and chemicals in the atmosphere.)

In the unlikely event of failure of fabric during the five (5) year period from date of original installation, we will supply you, the original owner or the provider of your protective fabric accessories with replacement fabric at no charge.

This warranty protects you against damage to the fabric accessories used under normal conditions. It does not cover damage to the fabric from acts of God, vandalism, neglect, exposure to harsh chemicals, faulty installation, exposure to excessive air pollution or harmful environmental conditions. This warranty does not cover damage from dirt or surface mildew that can be cleaned and removed.

This warranty is in lieu of all warranties expressed or implied, and Herculite Products Inc. will not be liable for any consequential or incidental damage. Any implied warranties imposed by law are limited in time to the duration of the expressed warranty.

Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damage, so, the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
